1. The Government of the People's Republic of Bangladesh has received a loan from the Asian Development Bank (ADB) toward the cost of Dhaka Water Supply Sector Development Project. Part of this loan will be used for payments under the contract named above. This contract will be jointly financed by ADB and the Government of Bangladesh (GoB). Bidding is open to bidders having requisite experience in water supply pipeline design and installation from eligible source countries of the ADB.
2. The Dhaka Water Supply and Sewerage Authority (DWASA) represented by the Project Director, Dhaka Water Supply Sector Development Project (DWSSDP), (Employer) invites sealed Bids from eligible bidders having requisite experience in water supply pipeline design, trenchless technology and installation for the construction of "Rehabilitation of Distribution Networks, Contract No. ICB-02.4 (Facilities). The completion period is 972 days. International competitive bidding will be conducted in accordance with ADB's "Single-Stage" Two-Envelope Bidding Procedure.

4. To purchase the bidding documents in English, eligible bidders should:
 - a. visit the office of Dhaka Water Supply Sector Development Project (DWSSDP) at the address above and pay a non-refundable fee of BDT. 10,000- or US\$ 150-;or
 - b. contact the office of DWSSDP at the address above and request for delivery by courier. The DWSSDP will advise on the additional fees to cover courier services. The method of payment will be by Demand Draft or Pay Order in favor of 'the Executing Agency (DWASA), Dhaka Water Supply Sector Development Project.' Upon receipt of payment, the document will be sent by courier to the Bidders or their representatives. No liability will be accepted for loss or late delivery.

5. The Employer will arrange for a pre-bid meeting to be held over a two day period from 6-7 October 2010. Attendance at the pre-bid meeting is greatly encouraged for the bidders and their specialist subcontractors for the trenchless technology work. If requested, the Employer will issue a letter of invitation to support a visa application on behalf of the bidder up to one week before the pre-bid meeting date. To assist in the planning for the meeting, it is requested that the bidders within seven days after purchasing the document advise the undersigned on the number of people that will be attending.
6. Bids must be delivered to the address below at or before **2:00 pm on 11 November 2010**. All Bids must be accompanied by a Bid Security of BDT 40,000,000 or an equivalent amount in US\$, or an equivalent amount in other freely convertible currency. The source of exchange rate shall be: Sonali Bank Ltd, Dhaka, Bangladesh. The date for the exchange rate shall be: 28 days prior to the submission of the Bids. The selling rate will be used.
7. Bids will be opened at **2:30 pm on 11 November 2010** in the presence of bidders' representatives who choose to attend.
8. When comparing Bids, ADB's Domestic Preference Scheme will be applied in accordance with the provisions stipulated in the Bidding Document.
